



**Interstate 81 Widening
Exit 137 to Exit 141
Roanoke County and City of Salem**
Virtual Design Public Hearing

Find out about a project to provide additional capacity and improve safety by widening 5.14 miles of Interstate 81 from two lanes in both directions to three lanes in both directions. The section of I-81 extends between mile markers 136.6 and 141.8 in Roanoke County and City of Salem. New lanes will be built at locations along I-81's right and left shoulders. This project will involve a change and/or break in limited access.

The hearing will be held as a **virtual/online** event. VDOT representatives will make a presentation beginning at 5 p.m. and be present to answer questions through the WebEx Chat function after the presentation is completed. The presentation will be available for review throughout the comment period.
