This project provides operational improvements to the existing interchange. Both the northbound and southbound Interstate 81 deceleration-ramps will be widened to provide designated left and right-turn lanes. The ramp intersections with Route 606 will be improved with lane markings to provide channelization. A lane will be striped out on Route 606 west of Interstate 81 to provide area for truck trailer tracking. This project is being coordinated with the Interstate 81 Corridor Improvement Plan. It is included with two I-81 CIP bundled ramp extensions: northbound exit 205 acceleration lane (UPC 115801) and southbound exit 205 acceleration lane (UPC 116245).

A contract valued at \$4,695,094.60 was awarded to A & J Development and Excavation Inc. of Mount Crawford, Virginia. The contract award date was July 1, 2021.
